Sir, In accordance with the
instructions of his Excellency
The Governor directing me to
furnish a return of the number
of Aboriginal Blacks who have
been received on Cockatoo Island
as Prisoners for the last 5 years
I have the honor to forward you
for His Excellency's information
a return of all the Aboriginal
Prisoners who have been
received on that island
since it became a Penal
Establishment by which it
will be seen that most of them

them have died within a short period of their arrival on the Island.

Five of these men have - 2

actually died on the Island

as it was customary in -

former years to remove all

prisoners who were seriously

ill to the General Hospital.

It is however quiet confronting

that the confinement of -

Aboriginal Blacks in the

Ordinary penal establishments

serious affects their health

and constitution and leads

ultimately to decay and death.
